Please advise me if copies of these documents are available, and if they can be sent to me. Thank you very much for your kind cooperation.

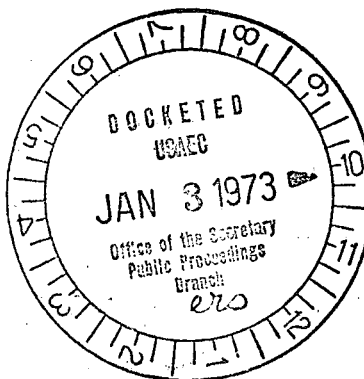
