ANSWER OF AEC REGULATORY STAFF TO PETITION FOR LEAVE TO INTERVENE OF THE ATTORNEY GENERAL OF THE STATE OF NEW YORK

On October 25, 1972, a "Notice of Consideration of Issuance of Facility Operating License and Notice of Opportunity for Hearing" in subject proceeding was published in the <u>Federal Register</u> (37 F.R. 22816). The notice specified that any petitions for leave to intervene must be filed within thirty days of the date of publication of the notice in the <u>Federal</u> Register.

Petitions for leave to intervene were filed by the Hudson River Fishermen's Association; Save our Stripers; Cortlandt Conservation Association, Inc.; Mary Hays Weik, and the State of New York, through the Counsel to the Atomic Energy Council of the State of New York. Subsequently, on March 27, 1973, the Atomic Safety and Licensing Board designated to review petitions for leave to intervene admitted as intervenors in this proceeding the Hudson River Fishermen's Association; Save Our Stripers, and the State of New York, which had petitioned to intervene under 10 CFR, Section 2.714 of the

On April 27, 1973, the staff received a copy of a "Petition of the Attorney General of the State of New York for Intervention," dated April 19, 1973. The petition was filed pursuant to Section 274 of the Atomic Energy Act of 1954, as amended. Attached to such petition was an affidavit of Peter Skinner, Environmental Engineer in the Office of the Attorney General, in support of the petition.

The Attorney General's contentions are environmental in nature, and reflect concern with possible impingement, entrainment, and behavioral modifications which will allegedly be caused by operation of Indian Point 3. The contentions are almost identical to those of the presently admitted intervenors.

As justification for the late filing of the petition for leave to intervene, the Attorney General indicated that it was waiting for publication of the regulatory staff's Draft Environmental Statement and had expected a decision on Indian Point 2 prior to this time. In addition, the Attorney General stated that his intervention "will not prejudice the rights of any party to this proceeding."

Since the State of New York has already been admitted as an intervenor in subject proceeding, the regulatory staff has no objection to the admission. of the Attorney General as an intervenor, confident that such intervention will not result in duplicative or repetitive evidence. The staff suggests that at a prehearing conference the Attorney General advise the Board and parties as to the details of his representation in this hearing, and the possibility of consolidation of the New York State interventions under 10 CFR, Section 2.715a of the Commission's Rules.


