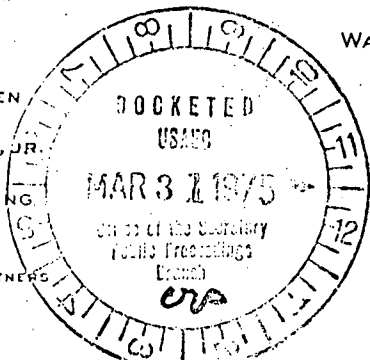

Gentlemen:

The following information is submitted in response to Chairman Jensch's letter to me of March 10, 1975:

1. Operating History of Indian Point Unit No. 1 and No. 2 facilities for the intervals from May 1 through July 31 for each of 1973 and 1974.

The operating history of Indian Point Units 1 and 2 for the periods requested is being sent to each of you under separate cover today. The information provided was extracted from Semi-Annual Operations Reports 22, 23, and 24, which were previously submitted to the Commission.

2. Projected Operations of the Indian Point Units for the intervals from May 1 through July 31 for each of the years 1975-1980.
