1. I am a Vice President of Consolidated Edison Company of New York, Inc. ("Con Edison"), 4 Irving Place, New York, N. Y. 10003. I make this affidavit in support of Con Edison's "Motion for Fuel Loading, Subcritical and Low Power Testing and Limited Operating License".

2. My responsibilities include: a) being the principal representative of Con Edison in environmental matters; b) keeping current with the state of the art, regulations, and legislation in the environmental area and translating these into environmental goals, policies, programs, and procedures; and c) directing biological investigations and research related to present or planned land, water or air use. I have participated



since September 1, 1974 in the proceedings concerning environmental matters relating to the licensing of Indian Point Units 2 and 3.

3. I am familiar with the activities which Con Edison proposes to conduct pursuant to the requested authorization as set forth in the affidavit of William J. Cahill, Jr., sworn to on March 10, 1975, and with the potential environmental effects of those activities. In view of the abundance and widespread distribution of the important species of aquatic life in the Hudson River as determined from recent ecological investigations, including impingement and entrainment studies at Indian Point Units 1 and 2, and in view of the limited cooling water requirements for the greater portion of the period during which those activities will be conducted, it is concluded that those activities will not result in any significant or irreversible adverse impacts on the aquatic ecosystem of the Hudson River. In addition, if contingencies should require modification of the optimum schedule as described in Mr. Cahill's Affidavit of March 10, 1975, further limited extensions of time for completion of those activities will not result in significant or irreversible adverse impacts on Hudson River biota.

The Atomic Safety and Licensing Board requests the Applicant to transmit to the Board and parties the following:



A report on the operating history, including length of time of each period or periods of operations, the interruptions and length of time thereof, and the power level or power levels for each time period for the Indian Point No. 1 and 2 facilities for the intervals from May 1 through July 31 for each of 1973 and 1974.
2. A projection for the same time periods in request No. 1 of the proposed operations for the Indian Point Nos. 1, 2, and 3 facilities for 1975 through 1980.
3. Copies of all of the Village of Buchanan zoning or building permits and/or similar license permits issued for the Indian Point No. 1, Indian Point No. 2, and Indian Point No. 3 facilities.
