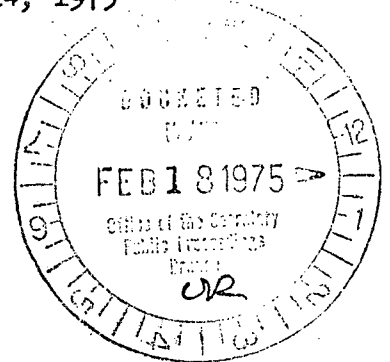

Dear Sirs:

The Atomic Safety and Licensing Board will issue a notice of hearing for the last session of data presentation to convene at 2:00 P.M. on Monday, March 24, 1975, at the Springvale Inn. Consistent with the Commission's direction, the parties and their attorneys are informed that the Atomic Safety and Licensing Board for the Monday session will consist of two members, due to the unavoidable conflict with that schedule had by one of the technical members, Dr. Franklin C. Daiber. Other sessions of the proceeding will have all three members present.

The Board suggests that at the Monday afternoon session, the data on quality assurance, plant security (with no in camera presentation) and financial qualifications be presented. In order to complete this agenda, the session may extend into the early evening without a dinner break. The sessions after Monday may conveniently concern the presentation of environmental data to be presented.

In order to permit advance review of the data intended to be presented, the Board also suggests that as the data, or the segments of the intended presentations are completed, that the mailing or delivery thereof be undertaken. This process will aid in the review and expedite the proceeding.

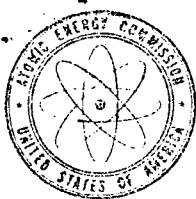
