
Gentlemen:

I am sending herewith to Chairman Jensch a duplicate original stipulation dated January 13, 1975, bearing the signatures of counsel for each of the parties to this proceeding. A copy of the stipulation is being enclosed for Mr. Briggs and Dr. Daiber, and a duplicate original is being filed with the Secretary.

The stipulation withdraws the requests for hearing in this proceeding and contains a license condition governing operation of the plant with once-through cooling. The license condition is subject to approval by this Board and the Appeal Board.

Applicant requests that the Board convene a pre-hearing conference to establish such further procedures as may be required by the Board to authorize the issuance of an operating license as provided in the stipulation. I am advised that counsel for the Regulatory
