BACKGROUND:

In order to obtain approval of its decommissioning plan (DP), the licensee provided a phased approach to decommissioning, and a schedule for each phase. The licensee is not quite half way through Phase 1 (remediation of Pond 3)

January 2007, the licensee informed the U.S. Nuclear Regulatory Commission (NRC) that at the completion of Pond 3 remediation, it intends to cease all remediation activities "... until sufficient funds are in place to completely address Pond 2 Phase 1 activities in late 2010 and 2011."

DISCUSSION:

FMRI presented all of the financial data NRC requested, including [Redacted]

[Redacted] cash flow from present through completion of Phase 1 activities, (b)(5)

Because of decommissioning activities in Pond 3, concentrations of uranium increased in one downstream monitoring well. Review of site procedures, recent licensee sampling data, and split samples taken during the site inspection in June 2007 shows that the interceptor trench captures all ground water, which is then treated before FMRI releases it through its Oklahoma Pollutant Discharge Elimination System permitted outfall. The licensee stated that there would not be any significant change in environmental conditions resulting from the delay. Staff agrees with that assessment.
