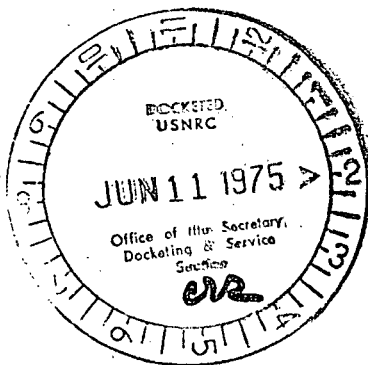
Re: Indian Point 3

Dear Harry:

This letter will confirm the correspondence and several telephone conversations between yourself and the attorneys for the Hudson River Fishermen's Association and Save Our Stripers concerning the latter's agreement to Con Edison's proposed request for an extension of the interim operating license and will confirm HRFA's and SOS' acceptance of the language set forth in your letter of June 5, to which Con Edison has agreed.

You have requested the agreement of the Hudson River Fishermen's Association and Save Our Stripers to Con Edison's proposed request for an extension to September 30, 1975, of the existing authority to issue an interim operating license. We have no objection to the proposed request based on the following agreed upon conditions:

During fuel loading and subcritical testing at Indian Point 3, the pumps at the plant intake will be operated in June and July only insofar as necessary to the program of fuel loading and subcritical testing or for testing of systems to support the power ascension program (including testing of the pumps) as outlined in Section 13 of the Final Safety Analysis Report or as required under the Technical Specifications or in accordance with the thermal studies or biological testing program previously approved by a government agency.

In all cases the minimum number of pumps and flow rate necessary to the relevant testing program will be employed. I also understand that when subcritical testing is completed, the pumps will be operated as necessary and appropriate for initial criticality and subsequent testing and subsequent power operations in compliance with the Stipulation among the parties dated January 13, 1975. Con Edison will provide to HRFA at the end of June and again at the end of July a list of when and how the pumps at the intakes to Indian Point 3 were used and pursuant to which program.
