RESPONSE OF HUDSON RIVER FISHERMEN'S  
ASSOCIATION AND SAVE OUR STRIPERS TO  
APPLICATION TO AMEND OPERATING LICENSE.

By papers dated April, 1975, the Power Authority  
of the State of New York applied to the Commission to amend  
the operating license in the above-captioned proceeding.

The matters in controversy in this proceeding  
between the Hudson River Fishermen's Association and Save  
Our Stripers have been settled pursuant to a stipulation  
between the parties which is subject to the approval of the  
Atomic Safety and Licensing Board and the Appeals Board --

In paragraph 11 that stipulation states:

This stipulation shall be binding upon any  
successor-in-interest to the Applicant or  
any future co-applicant who shall come to  
hold or have any interest whatsoever in the  
operating licenses, and shall be binding  
upon any successor-in-interest to any of  
the parties hereto who have notice of terms  
thereof as if such successor-in-interest had  
been an original party hereto and their  
successors-in-interest regardless of the  
addition or substitution of parties to the  
proceeding.

In these circumstances HRFA and SOS request that any amendment to the operating license granted to the Power Authority of the State of New York take explicit notice of the terms of the stipulation and that the agreement of the Power Authority of the State of New York to the terms of the stipulation be made an explicit condition of any amendment to the operating license for Indian Point #3 which is granted by the Commission pursuant to this application.
