REMARKS: IMC 2681 (Physical Protection and Transport of SNM And Irradiated Fuel Inspections of Fuel Facilities) has been revised to emphasize the risk-informed, performance-based approach to inspections and (2) impose changes to inspection activities due to orders issued that have not been incorporated by rulemaking. This revision was a major rewrite, so changes are not indicated in red.

IMC 0609 App E Part I (Baseline Security Significance Determination Process for Power Reactors) has been revised to incorporate a decision tree for unsecured safeguards information findings and a significance screen for physical protection findings. In addition, the sections are reordered to follow the Figure 1 Baseline Security SDP Flowchart.

IMC 2600 (Fuel Cycle Facility Operational Safety and Safeguards Inspection Program) has been revised to incorporate Gas Centrifuge Facility inspections into the fuel facility inspection program.

IMC 2600 Appendix B (NRC Core Inspection Requirements, Tables 1 and 2) has been revised to incorporate Gas Centrifuge Facility inspections into the fuel facility inspection program.

IP 71130.14 (Review of Power Reactor Target Sets) is issued as a separate procedure rather than Addendum 6 to IP 71130.03, "Contingency Response - Force-on-Force Testing."

IP 35034 (Design Certification Testing Inspection) is issued to verify that testing activities, performed in support of design certification, are conducted in accordance with the applicable provisions of Appendix B of 10 CFR Part 50 and the applicable quality assurance program.
