Gentlemen:

This refers to the inspection conducted by Mr. T. Rebelowski of this office on August 19-21, 1975 at Indian Point Unit 3, Buchanan, New York of activities authorized by NRC License No. CPPR-62 and to the discussions of our findings held by Mr. Rebelowski with Mr. Kohler and Mr. Stein and members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no items of noncompliance were observed.


