Gentlemen:

This refers to the inspection conducted by Mr. Rebelowski and Mr. Canter of this office on March 19-21, 1975 at the Indian Point 3 Nuclear Power Station, Buchanan, New York of activities authorized by AEC License No. CPPR-62 and to the discussions of our findings held by Mr. Rebelowski with Mr. Perry and Mr. Zulla of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection, it was found that certain of your activities appeared to be in noncompliance with NRC requirements. The items and references to the pertinent requirements are listed in the IE Inspection Report which is enclosed with this letter. We note that one of these Items of Noncompliance was identified through your internal audit program and corrective action was initiated. No additional information is needed on this item at this time.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. If this report contains any information that you (or your contractor) believe to be proprietary, it is necessary that you make a written application within 20 days to this office to withhold such information from public disclosure. Any such application must include a full statement of the reasons on the basis of which it is claimed that


