This refers to the inspection conducted by Mr. Martin of this office on December 16-20, 1974 at Indian Point 3 Station, Buchanan, New York of activities authorized by AEC License No. CPPR-62 and to the discussions of our findings held by Mr. Martin with Mr. Coulbourn and members of your staff at the conclusion of the inspection, and to subsequent telephone discussions between Mr. Perry of your staff and Mr. Martin on January 2, 1975, and between Mr. Josiger of your staff and Mr. Martin on January 3, 1975.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or safety items were observed.
