Gentlemen:

This refers to the inspection conducted by Mr. Everett of this office on December 11 and 12, 1974 at the Indian Point Nuclear Power Station of activities authorized by AEC License Nos. CPPR-62 and DPR-26 and to the discussions of our findings held by Mr. Everett with Mr. Stein and Mr. Kelly of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.


Within the scope of this inspection, no violations or safety items were observed.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room.
