Gentlemen:

This refers to the inspection conducted by Mr. King of this office on November 7-8, 1974 at the Indian Point Station of activities authorized by AEC License No. CPPR-62 and to the discussions of our findings held by Mr. King with Mr. S. Zula at the conclusion of the inspection.

The area examined during this inspection was limited to the physical protection program to be established in connection with the receipt of fuel for Unit 3. Within this area, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or program weaknesses were observed.

In accordance with Section 2.790(d) of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, documentation of your control and accounting procedures for safeguarding special nuclear materials and your facility security procedures are exempt from disclosure; therefore, the inspection report will not be placed in the Public Document Room and will receive limited distribution.
