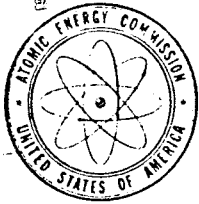

This refers to the inspection conducted by Mr. Heishman of this office on May 21, 1974 at Westinghouse Cheswick, Pa. plant of activities authorized by AEC License No. CPPR-62 and to the discussions of our findings held by Mr. Heishman with Mr. Deane of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Regulatory Operations Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations or safety items were observed.

In accordance with Section 2.790 of the AEC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the AEC's Public Document Room.
