- A. The inspector stated that the purpose of the meeting was to review the scope of the Quality Assurance Program and to obtain a commitment for its completion.
- B. The inspector discussed the overall scope of the QA program necessary to implement Appendix B, 10 CFR 50 requirements for the operations phase. This included detailed discussions of applicability to all quality affecting activities, and details of the procedures and procedural controls required to implement the program.

C. The licensee stated that he would evaluate the actions necessary to detail his program to meet AEC requirements and would discuss this and the date for program completion with RO:I on February 15, 1974.
