Dear Sir:

Reference (1) transmitted the NRC's Notice of Violation (NOV) and Proposed Imposition of Civil Penalty regarding the Indian Point 3 (IP3) Security Program. As required by the NOV, Attachment I to this letter provides the Authority's "Reply to the Notice of Violation," and as stated in the NOV contains details of IP3's security program that have been determined to be exempt from public disclosure in accordance with 10 CFR 73.21 (Safeguards Information). Also enclosed is a check in the amount of twenty-five thousand dollars (\$25,000) in payment for the proposed civil penalty.

As brought out in your letter (Reference 1), prior performance in the security area has been good, as evidenced by Category 1 ratings in security during the last five SALP periods. The management structure and the senior security managers who achieved these results remain in place. The IP3 Resident Manager has met with the security managers and the security officers. These people individually and collectively acknowledge that their professional reputation has been diminished by the performance described in the NOV. The Authority reaffirms its commitment to the highest standards in the security area.

Nevertheless, the Authority is in agreement that improvements are needed in the security program at IP3 and


