Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. 552, I am requesting a list of all U.S. Atomic Energy Commission (AEC) and/or U.S. Nuclear Regulatory Commission (NRC) licensees who operated facilities within a five mile radius of Fords, New Jersey, at any time prior to 1980. I am also requesting access to or copies of all identified licensees' corresponding docket files. Cities located within a five mile radius of Fords, New Jersey, include but are not limited to: Avenel, Carteret, Charleston, Colonia, Edison, Fords, Highland Park, Hopelawn, Iselin, Keasbey, Madison Park, Metuchen, Parlin, Perth Amboy, Port Reading, Sayreville, Sewaren, South Amboy, and Woodbridge.

To the extent that any relevant documents are classified, I request that they be declassified and/or sanitized for my review. If there are classified documents which will not be declassified and/or sanitized, I request that you identify any and all such documents by listing date, author, recipient(s) and unclassified subject matter.

I understand that the volume of material responsive to my request may be large. History Associates is willing to coordinate with you to respond to this request as expeditiously as possible. History Associates agrees to pay all reasonable and standard processing fees authorized by 5 U.S.C. 552(a)(4)(A) and the applicable regulations up to \$250.
