Dear Mr. Cahill:

Reference is made to the letters I sent to Mr. Harry Woodbury on August 12 and 13, 1974. Reference is also made to your letters to the AEC, dated July 25, July 29, July 31, August 22, August 30 and September 5, 1974.

Upon review of the various reports you have sent us within the last two months and those listed in your letters referenced above, we find that certain documents that were due us have not yet been received. They are listed in Attachment I along with the date of availability.

In order to maintain our review schedule, we will need these documents within seven days of receipt of this letter. Your reply should consist of three signed originals and seven additional copies. Please send two copies directly to Dr. Richard Rush at Oak Ridge National Laboratory.

As requested in our letter of August 12, would you please arrange to send copies of the document "First Annual Report on the Impact of the Bowline Generating Station on the Hudson River Aquatic Ecology 1973 Program," prepared by Quirk, Lawler and Matusky. Furthermore, would it be possible to obtain the reports "Aquatic Ecology Studies-1973 Roseton/Danskammer" and "Impingement and Entrainment Studies-1973 Danskammer" as listed in H. Voigt's letter of January 18, 1974 to N. A. Robinson. We also understand that QIM has prepared a report entitled "Compensation" dated March 15, 1974, and that Consolidated Edison submitted a document "The Contribution of the Hudson River Striped Bass to the Mid-Atlantic Fishery," dated March 21, 1974, as a memorandum for the record of the hearings on the Cornwall Pumped Storage Project held by the Subcommittee on Fisheries and Wildlife Conservation and the Environment of the House Committee on Merchant Marine and Fisheries, February 19 and 20, 1974. Would you please submit copies of these reports for our review of ecological behavior of aquatic biota in the Hudson River.
