Telephone call to Dr. William Seaman, American Cyanamid Company, Bound Brook, N.

Called regarding Dr. Seaman's letter in answer to our letter of August 12 in which he states that he desires to have a possession limit of 55 curies for the material which will be produced in the service irradiation of silica samples. He said that they will pick up the material at Brookhaven within a matter of hours after removal from the reactor. He said they are working on procedures for transferring the material from the shipping container to the facility. I requested a copy of these procedures due to the large quantity of activity they will be handling. Dr. Seaman said they were not rushing into this thing and were planning carefully and would submit information as soon as procedures are in better shape. Application Control No. 6664 will be held pending.
