NRC's HANDLING AND MARKING OF SENSITIVE UNCLASSIFIED INFORMATION OIG-03-A-01

Status of Recommendations

Recommendation 1:

Update the guidance for Official Use Only (OUO) documents to require clear identification of sensitive unclassified information to prevent its inadvertent disclosure.

Agency Response Dated December 22, 2009:

The NRC issued OUO guidance on October 26, 2005, when: it issued Yellow Announcement No. 77, "NRC Policy and Procedures for Handling, Marking, and Protecting Sensitive Unclassified Non Safeguards Information (SUNSI)." The SUNSI policy and handling procedures are available to staff through the NRC's **SUNSI Program** internal Web page. The **SUNSI Handling Requirements Summary Tables contain** guidance for appropriately marking documents within each of the seven SUNSI handling groups. Additionally, marking guidance is also discussed in the Frequently Asked Questions link on the SUNSI Program Web page. Paragraph D.1. "Marking," of the NRC Policy for Handling, Marking, and Protecting SUNSI specifies that documents containing SUNSI must be properly marked and directs staff to the marking guidance on the SUNSI Handling Requirements Web page identified above.

On July 1, 2009, staff from the Office of Information Services provided SUNSI marking refresher training to the headquarters and regional SUNSI points of contact. In addition to this training, an NRC daily announcement, Policy Reminder: NRC Policy for Handling, Marking, and Protecting Sensitive Unclassified Non-Safeguards Information (SUNSI), was issued on June 9, 2009.

OIG Response:

OIG reviewed the Yellow Announcement dated October 26, 2005, and the NRC daily announcement issued on June 9, 2009, and determined that the guidance has been updated. This recommendation is therefore considered.

Status of Recommendations

Recommendation 2:

Mandate consistent use of defined markings on documents containing OUO information and clarify the markings that should be used on sensitive unclassified information.

Agency Response Dated December 22, 2009:

Guidance for consistent use of defined markings on containing OUO information and clarification of the markings that should be used on sensitive unclassified information was issued October 26, 2005, through Yellow Announcement No. 77, "NRC Policy and Procedures for Handling, Marking, and Protecting Sensitive Unclassified Non Safeguards Information (SUNSI)." The SUNSI policy and handling procedures are available to staff through the NRC's SUNSI Program internal Web page. The SUNSI Handling Requirements Summary Tables contain guidance for appropriately marking documents within each of the seven SUNSI handling groups. Additionally, marking guidance is also discussed in the Frequently Asked Questions link on the SUNSI Program Web page. Paragraph D.1.
