**JOINT INTERVENORS RESPONSE TO MARYLAND PPRP LETTER**

The response by the State was filed late and thus should be dismissed without consideration.

If the ASLB does not consider the response by the State to be untimely, then the response should be rejected. It is not supported by demonstrable evidence that the correct volumes were used in the formulas. Simply stating that these values are just "typographical errors" which occur in various tables and text of the PPRP study does not demonstrate whether the calculations and computations by PPRP and Unistar are indeed correct and accurate. The main purpose for the 2006 PPRP study was to corroborate the FERC decision to approve the DCPLNG expansion in proximity to the existing Calvert Cliffs nuclear facility, not to justify the siting of CCNPP3 in the Calvert Cliffs footprint.
