Dear Mr. Pollock:

On January 19, 2010, the U.S. Nuclear Regulatory Commission (NRC) completed an Independent Spent Fuel Storage Installation (ISFSI) security inspection at the Indian Point Energy Center. The inspection covered the NRC's Additional Security Measures (ASMs) for the Physical Protection of Dry Independent Spent Fuel Storage Installations. The enclosed inspection report documents the inspection results, which were discussed on December 17, 2009, with Mr. Robert Walpole, and other members of your staff. A follow-up telephone call was conducted with Ms. Ann Stewart on January 19, 2010.

The inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

Based on the results of this inspection, no findings of significance were identified.
