AMENDMENT NO. 2 TO
APPLICATION FOR AMENDMENT TO
OPERATING LICENSE

On February 9, 1979, Consolidated Edison Company of New York, Inc. ("Consolidated Edison"), as holder of Facility Operating
License No. DPR-26, filed with the United States Nuclear
Regulatory Commission ("NRC") an "Application for Amendment
to Operating License", sworn to by Mr. William J. Cahill, Jr.
on February 9, 1979. That Application requested changes to
Table 3.12-1 of the Indian Point Unit No. 2 Technical Specifications
to reflect redesign of the support systems of certain safetyrelated pipe lines for the purpose of improving the reliability
of those support systems. By Amendment No. 55 to DPR-26, dated
June 12, 1979, the NRC Regulatory Staff issued its approval of
a significant portion of the proposed support system redesigns
and deferred consideration of the remaining portion to a future
time.

On December 31, 1979, Consolidated Edison filed with the NRC
"Amendment No. 1 to Application for Amendment to Operating
License" which modified the February 9, 1979 Application
to reflect completion of plant modifications approved by
Amendment No. 55, seismic reanalyses of certain pipe lines,
and certain editorial and technical changes. Attachment
A to the December 31, 1979 Amended Application provided
a complete package of updated proposed Technical Specification
page changes for both Table 3.12-1 and Specification 4.12.1.
These updated page changes incorporated those changes still
outstanding from the original February 9, 1979 Application.

The present "Amendment No. 2 to Application for Amendment to Operating License" modifies proposed pages 2 of 14, 3 of 14 and 11 of 14 of Table 3.12-1 as contained in Attachment A of the December 31, 1979 Amended Application to reflect additional support system redesign for two safety-related pipe lines.

Attachment A to the present Amended Application contains the specific revised page changes for pages 2,3 and 11 of Table 3.12-1. All other proposed technical specification page changes remain as presented in the December 31, 1979 Amended Application.

A Safety Evaluation of the proposed changes is set forth in Attachment B to this Amended Application. This evaluation demonstrates that the proposed changes do not represent a significant hazards consideration and will not cause any change in the types or an increase in the amounts of effluents or any change in the authorized power level of the facility.
