This Application requests an amendment to the Indian Point Unit No. 2 Technical Specifications to remove the requirement of waiting 400 continuous hours after reactor shutdown before unloading more than one region of fuel assemblies. The purpose of the request is to afford greater flexibility in the scheduling of refueling activities in future outages, and to permit a more expeditious full core discharge should it become necessary due to unforeseen circumstances.
