APPLICATION FOR AMENDMENT
TO OPERATING LICENSE

Pursuant to Section 50.90 of the Regulations of the Nuclear Regulatory Commission (NRC), Consolidated Edison Company of New York, Inc. (Con Edison), as holder of Facility Operating License No. DPR-26, hereby applies for amendment of the Technical Specifications contained in Appendix A of that license.

Specifically, we request that new Technical Specifications 3.17 and 4.21 be added to establish limiting conditions for operation (LCOs) and surveillance requirements for the Alternate Safe Shutdown System. These changes were requested by the Regulatory Staff as a result of its review of the Indian Point 2 evaluation of fire protection of safe shutdown capability for Section III.G of 10 CFR 50, Appendix A. These changes supersede those in our August 7, 1981 Application, which was returned for resubmittal by letter dated November 15, 1983 (S. A. Varga to J. D. O'Toole).

The specific proposed Technical Specification revisions are set forth in Attachment A to this Application. A Safety Assessment of the proposed




