Transmitted herewith are three (3) originals and forty (40) copies of "Application for Amendment to Operating License", sworn to on August 6, This Application is in response to your April 22, 1985 letter requesting the inclusion of an anticipatory reactor trip upon turbine trip specification in the Indian Point Unit No. 2 Specifications, which satisfies NUREG-0737, "Clarification of TMI Action This Application requests Plan Requirements" Item II.K.3.12. amendment to the Indian Point Unit No. 2 Technical Specifications to include the anticipatory reactor trip upon turbine trip. In addition, application requests a modification to bypass (block) the anticipatory reactor trip upon turbine trip below 35% power and provides the necessary analyses, required by NUREG-0737 Item II.K.3.10, which demonstrates that the probability of a small break loss-of-coolant accident (LOCA) resulting from a stuck-open power-operated relief valve (PORV) is substantially unaffected by the modification. The modification of this trip can lead to an increase in plant availability by reducing the length of time required to restart the unit following a readily correctable turbine trip at low power.

To permit us to implement the proposed modification to the anticipatory reactor trip upon turbine trip during the Cycle 7/8 refueling outage, Con Edison requests that the necessary license amendment be issued no later than December 31, 1985.
