Transmitted herewith are the original and two (2) copies of an "Application for Amendment to Operating License," sworn to on December 28, 1988. This Application requests an amendment to the Indian Point Unit No. 2 ("IP-2") Technical Specifications. The proposed amendment, as set forth in Attachment I to this Application, revises Section 4.16.A to include an additional test requirement for Safety Injection System low head injection line check valves 897A-D and Residual Heat Removal check valves 838A-D. This action, when approved, will rescind the February 11, 1980 Confirmatory Order Item A.5 as discussed in the July 5, 1985 Rescission of the Confirmatory Order.

A safety assessment is presented in Attachment II to this Application and provides the "No Significant Hazards Considerations" analysis for the proposed amendment. Attachment III provides a description of certain editorial changes made which are administrative in nature.
