SUBJECT: Withdrawal of License Amendment Request Relative to Fan Cooler  
Unit Filtration Systems


By letter dated June 12, 1987, Consolidated Edison submitted to the NRC an application for amendment to the Indian Point Unit No. 2 operating license. This application requested an amendment to the Indian Point Unit No. 2 Technical Specifications which would revise the operability requirements of the containment fan cooler units, delete the requirements of their HEPA filters, charcoal adsorbers and associated fire protection and detection equipment, and revise the amount of time one containment spray pump may be inoperable.

By letter dated August 3, 1987, Consolidated Edison transmitted a revised No Significant Hazards analysis to supplement that application. By letter dated May 10, 1988, the part of that application relative to containment fan cooler operability was withdrawn. By letter dated June 29, 1988, the NRC forwarded Amendment No. 132 to Facility Operating License No. DPR-26 for the Indian Point Nuclear Generating Unit No. 2. That amendment revised Sections 3.3.B and 5.2.C of the Technical Specifications as requested.

Consolidated Edison hereby withdraws the balance of the proposed amendment transmitted in the June 12, 1987 application. Subsequent to certain reanalyses and firming up our plans for plant modifications, a topic we plan to discuss with the staff in the near future, we will consider resubmittal of this part of the application in the Fall of 1989.
