This letter provides schedule information on one of our NUREG-0737 Supplement 1 commitments and clarifies a schedular error in your Confirmatory Order addressing NUREG-0737 Supplement 1 commitments dated June 12, 1984.

In our letter of March 14, 1984 we informed you that by July 31, 1984 we would complete our schedule reassessment and provide you with a date for submittal of a final version of the Indian Point 2 Detailed Control Room Design Review (DCRDR) Summary Report. The schedule reassessment, which considered the integration of the other NUREG-0737 Supplement 1 initiatives and was discussed with NRC reviewers at a meeting held on June 26, 1984, concluded that the date for submittal of the Indian Point DCRDR Summary Report will not change from our commitment of June, 1986 made in our April 15, 1983 submittal.

On April 15, 1983 we responded to NRC Generic Letter 82-33 (December 17, 1982) pursuant to 10 CFR 50.54(f) furnishing you with a proposed schedule for completing each of our commitments to the basic requirements for the items identified in Supplement 1 to NUREG-0737. This response was subsequently supplemented by letters dated August 31, 1983, November 18, 1983, February 14, 1984 and March 12, 1984.

With respect to Supplement 1 to NUREG-0737 item titled "Regulatory Guide 1.97 (R.G. 1.97) - Application to Emergency Response Facilities" Con Edison in all the abovementioned letters did not make a schedular commitment to implement the conclusions of the R.G. 1.97 summary report

describing how the requirements of Supplement 1 to NUREG-0737 have been or will be met by December, 1985 as stated in the attachment to the June 12, 1984 Confirmatory Order (page 1 of the attachment, item 3b and page 2 of the attachment, item 5 footnote). In fact in the first paragraph of page 1-20 of our April 15, 1983 submittal we stated, in part, "However, following completion of the Regulatory Guide 1.97 review and any initial design efforts that may be required as a part of it, finalization of the implementation schedule will then be possible."

We also note that, in paragraph I of the Order, "Confirming Licensee Commitments on Emergency Response Capability," there is an incorrect reference to Indian Point No. 2's facility operating license number which is DPR-26 and not DPR-64.

Accordingly, we suggest that an amendment to the Confirmatory Order dated June 12, 1984 would be appropriate prior to September, 1985.
