

1. Provide clarifying information on solid radioactive waste to compare annual generation with the FES.

Response

A review of the past several years of data for Indian Point Unit No. 2 (IP-2) indicates that there has been a steady decrease in the annual volume of solid radwaste. The 1986 volume is the lowest since Unit No. 2 began operation. We are more than meeting our projected goals and expect to further minimize the generation and volume of these solid wastes.

2. Provide information on extending the State Pollutant Discharge Elimination System (SPDES) permit.

Response

By law, our SPDES permit must be renewed every five years by making application to the New York State Department of Environmental Conservation. The current permit was issued on May 14, 1981 and expired on May 13, 1986. Con Edison timely applied for a SPDES renewal permit for IP-2 on January 17, 1986. Pursuant to New York State Law, State Administrative Procedure Act Section 401.2, an expired SPDES permit continues in force and effect while a new permit application is being processed. We expect that subsequent SPDES permits will be issued in 1992, 1997, 2002, etc.
