The purpose of this modification is to provide funding for Tasks 2, 4, and 5 in the amounts of \$800,000, \$214,000, and \$300,000, respectively.

Accordingly, the following changes are hereby made to the contract:

1. Section B, CONSIDERATION AND OBLIGATION, Paragraph (3) is hereby deleted in its entirety and replaced with the following [specific changes are identified in italics]:

- (3) The amount presently obligated with respect to this order is ***\$17,074,653.23***. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

Of the ***\$17,074,653.23*** amount funded, funds are obligated to each task as follows:
