It has come to our attention that Amendment No. 92, issued on January 27, 2008, contained an error, in that the authorization for your cesium-137 instrument calibration device was inadvertently not listed in License Condition 10 for your new location of use at 11141 Parkview Plaza Drive, Fort Wayne, Indiana. This change should have been made in accordance with your letter dated October 30, 2007.

Enclosed is a corrected copy of the most recent Amendment, No. 99, to your NRC Materials License No. 13-01284-02, which reflects this correction in License Condition No. 10.D. We apologize for any inconvenience this error may have caused you.

In addition, I updated the formatting used in License Condition No. 12.D. for your Authorized Medical Physicists.

Please note that the changes made to your license are printed in **bold** font, which include carryover from the original version of Amendment No. 99.
