SUBJECT: Third Ten-Year Interval Inservice Inspection
Program -- Piping Isometric Drawings

On January 24, 1994, in accordance with IWA-1400(c) of Section XI of the ASME Boiler and Pressure Vessel Code, Consolidated Edison submitted the Indian Point Unit 2 Inservice Inspection (ISI) Program Summary for the period July 1, 1994 through June 30, 2004, which is the third 120 month interval. We indicated in our January 24 submittal that Appendices A-C, plant drawings, were to be submitted subsequently. Appendices A and B were transmitted on February 8, 1994, and Appendix C is transmitted herewith to support NRC review of the program and the relief requests.

Appendix C contains full size ISI program isometric drawings. Due to their large size, the drawings are being transmitted only to the Document Control Desk, the NRC Indian Point Unit 2 Project Manager and the NRC's contract reviewer in Idaho. These transmittals are in accordance with NRC Project Manager and Resident Inspector direction. Additional copies are available upon request.
