On March 26, 1998, we issued Confirmatory Action Letter (CAL) 1-98-005 which documented commitments made by Con Edison, as detailed in a March 23, 1998, letter to the NRC prior to plant restart. On July 8, 1998, CAL 1-98-005 was revised to reflect additional commitments made by Con Edison, as detailed in a July 1, 1998, letter.


On September 1, 1998, you submitted a letter which documented your completion of the commitments made in the March 23, 1998 and July 1, 1998 submittals, specifically:

- 1) The completion of Restart Readiness Training for operators as detailed in Attachment A of the July 1, 1998, letter;
- 2) The completion of the Restart Action Plan (RAP) as detailed in Attachment B of the July 1, 1998, letter; and,
- 3) The completion of six addenda to the RAP approved after July 1, 1998.

The results of our inspections of the above commitments are or will be documented in NRC inspection reports 98-02, 98-04, 98-06, 98-08, 98-09 & 98-14.

Based upon your September 1, 1998, submittal and the results of our inspections, we found that you adequately completed the commitments contained in CAL 1-98-005 prior to the restart of Indian Point Unit 2 on September 3, 1998. Therefore, CAL 1-98-005 is considered closed.
