SUBJECT: SIMULATOR EXAMINATION CREW SIZE

I am responding to a telephone discussion on February 28, 1991, between Mr. Frank Inzirillo of your staff and Mr. J. Prell of my staff regarding the complement of candidates for simulator examinations administered as part of the initial licensing process. We understand that you desire to have the candidates evaluated in a normal Technical Specification configuration of two senior operators (SRO) and two reactor operators (RO). In the past (and as planned for the March 12, 1991 examinations), we normally evaluate a three person crew in the simulator.

The primary reason for evaluating three candidates at a time in the dynamic simulator examination is that the initial license examination is focused exclusively on evaluating the individual's knowledge, skills, and abilities to perform licensed duties on the subject plant. Unlike the requalification program, there is neither crew evaluation nor training program evaluation being simultaneously performed. It is our objective to evaluate an individual taking an initial license examination with the minimum shift manning allowed by the technical specifications. At Indian Point Unit 2, this would be the one required SRO in the control room, even though two SROs are required on shift and the two ROs required in the control room during startup and planned shutdowns. This allows us to make a licensing decision based on the most limiting licensed personnel constraints possible, thus making our decision on the basis of the individual's performance of hicensed duties.

Once operators are licensed, we expect that they are promptly enrolled in the facility's requalification program. It is there that crew training and evaluation should be further developed from the initial license training, as an operator may now train with his assigned crew. That is why crew evaluation is a segment of the NRC's requalification program evaluation.

Further, we are interested in evaluating the execution of the Emergency Operating Procedures on an initial examination. An SRO must be able to control plant activities through the use of the Emergency Operating Procedures without the

oversight assistance from an additional licensed individual. If the SRO candidate cannot demonstrate this ability, then this individual is not ready for an SRO license.

We and the Operator Licensing Branch at NRC Headquarters understand your position on this matter, but we continue to support three man crew evaluations as the most effective and conservative approach to take in making an initial licensing decision. If you have concerns over our examination methodology, you are encouraged to work through NUMARC and its representatives on this matter.





