**SUBJECT: NOTIFICATION OF CHANGES IN SENIOR REACTOR OPERATOR
STATUS; NOTICE OF VIOLATION**

By letter dated November 1, 1993, you informed the NRC that three senior reactor operators licensed to operate Indian Point Unit 2 had been diagnosed as having degraded vision such that corrective lenses should be worn when performing licensed duties. As these diagnoses occurred between November 22, 1992, and May 5, 1993, you did not meet our regulation that we be notified within 30 days of when you learned of such diagnoses. Accordingly, based upon the information supplied, we have concluded that your organization was not in full compliance with NRC requirements. A Notice of Violation is enclosed and categorizes the violation as Severity Level V in accordance with, "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C.

You are required to respond to this letter; and, in preparing your response, you should follow the enclosed instructions. In accordance with Section 2.790 of 10 CFR Part 2, a copy of this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
