The purpose of this letter is to submit markups to the ESBWR DCD, Tier 2, Appendix 3G Figures, which are the result of a GEH internal Corrective Action.

It was discovered during GEH internal reviews, that during preparation of ESBWR DCD Revision 6, critical dimension in Figures 3G.6-3 to 3G.6-6, 3G.6-19 & 3G.6-20 were not updated to reflect the General Arrangement drawings revised per an Engineering Change Authorization that made some changes to the partition walls in the RB/FB structure. This transmittal letter closes out a GEH Internal Corrective Action Item. These minor Appendix 3G figure changes will be incorporated into DCD Revision 7.

The revised pages to Appendix 3G are contained in Enclosure 1.

Enclosure 1 contains security-related DCD markups associated with this response.
