Dear Mr. Royston:

Enclosed is Amendment No. 13 to your NRC Material License No. 21-24710-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

**In correspondence dated November 9, 2009, and January 12, 2010, you indicated that you wished to release for unrestricted use the former storage location at 4400 S. Saginaw Street, Suite 1200, Flint, Michigan 48507.**

**The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former storage location and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this storage location and it is suitable for unrestricted use.**

**As a reminder, an NRC-approved license amendment is required before receiving, using, and storing licensed material at an address or location not included with the application or already listed on the license.**

**Please note that License Condition Nos. 13 and 21 have been added which do not add new requirements but highlight the regulatory requirements for establishing decommissioning financial assurance and particular conditions of portable gauge use, respectively.**

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
