1 Q. Thank you. That had thrown me a little.

2 Looking at second page then, the one that  
3 you think should be the first page chronologically, can  
4 you tell me -- which is identified as NRC 014-0897 --  
5 can you tell me what this is notes of?

6 A. This is notes of the phone call -- I believe  
7 this is notes of the phone call that we had with Brian  
8 Sheron in early October, late September, yes.

9 Q. That phone call, were you on the phone  
10 with -- I know that Guy Campbell and Brian Sheron had  
11 spoken on or about September 28th --

2 Q. Would Steven Moffitt have been on the  
3 phone?

4 A. I can't recall that he was.

5 I recall Dave Geisen and myself because we  
6 were sitting in the exit meeting for the INPO plant  
7 evaluation. Guy Campbell left the room and Geisen and  
8 I were sitting at the table and Campbell came back very  
9 agitated and said, "I want you and I want you," and he  
10 pointed to both of us. "Oh, great." You know, that  
11 type of thing, but I can't recall if we had Steve in  
12 there or not.

13 Q. Were you surprised by this call from Brian  
14 Sheron?

15 A. Yes.

16 Q. Why?

17 A. Because the phone call was of a context  
18 that, "We expect you to shut down, we want you to, we  
19 expect you to shut down." And it was a very -- I would  
20 characterize it as a very short and very abrupt  
21 communication from Brian Sheron, which is why we got  
22 into asking for further explanation, "let's have  
23 another phone call." So in that regard, yes, it was a
