The State of Iowa appreciates the opportunity to comment on PRM 32-6, regarding the regulation of tritium exit signs. We are in agreement with the Association of State and Territorial Solid Waste Management Officials (ASTSWMO) in the belief that revisions to NRC regulations and/or guidance to "improve the labeling and accountability of tritium exit signs" is necessary. Our position is that per regulations, the accountability should lie with the manufacturer to provide improved labeling, handling and disposal instructions and to ensure that an individual on the receiving end of a purchase is knowledgeable about the hazards of the material.
