Dear Ms. Vietti-Cook:

The Nuclear Energy Institute (NEI)<sup>1</sup> appreciates the opportunity to provide comments on behalf of the nuclear industry on the subject petition for rulemaking (PRM) requesting a change to the "unit outage" definition contained in 10 CFR Part 26 Subpart A.

NEI supports the petition to change the defined term to "site outage" to reflect more appropriately its applicability to multiple unit sites. NEI proposes that the definition of "site outage" be modified slightly from that provided in the petition to state "*Site outage* means, for the purposes of this part, up to one week prior to disconnecting a reactor unit from the grid and up to 75 percent reactor power following reconnection of that unit to the grid." While this aspect of the change, as stated in the petition, will extend the use of outage work hours, the exclusion period of 60 days for outages remains unchanged. Therefore, this change does not affect the cumulative fatigue impact assessed as part of the current rule.

The particular example used in the petition is the use of a super-crew on outage minimum days off in the shared control room of a dual unit site where the operators are licensed on both units. The application of outage minimum days off to operators in the on-line units at multi-unit sites is a matter that has been identified previously in discussions between the industry and NRC. NEI continues to believe this position would pose no additional risk and would provide for optimal resource availability to conduct safe operations and outages.

NEI is continuing to collect industry experience following initial implementation of the rule and believes other changes are warranted to address issues of complexity and unintended consequences of rule implementation. NEI intends to work with the NRC staff to pursue any additional changes that are needed to most effectively and efficiently manage work hours to ensure safe and reliable operation of the nation's nuclear units.
