The proposed change was based on control of the fire protection program and implementing procedures using the requirements of 10 CFR 50.59. The NRC staff stated in Reference 3 that no amendment could be issued because Technical Specification Amendment 157 was acceptable, in part, due to the addition of Technical Specification 6.5.1.6.m. This position has recently changed as evidenced by NRC letter of April 12, 1999 on Docket 50-333. That letter approved a Technical Specification change removing the equivalent of our specification 6.5.1.6.m on a plant with a prior amendment similar to our Amendment 157. The NRC letter noted that a similar amendment for Indian Point 3 amendment could now be authorized.

Based on this change in position, we respectfully request that you re-initiate review of our previous proposed Technical Specification change.
