ATTACHMENT I

As a result of NRC Bulletin No. 88-05 and its supplements, the Authority conducted a review of Indian Point 3 purchase orders for flanges and fittings to determine if any materials were supplied by West Jersey Manufacturing Company (WJM), Piping Supplies, Incorporated (PSI). This review consisted of 615 purchase orders from January, 1976 through June, 1988.

Out of the 615 purchase orders reviewed, one purchase order, 78-IP-1972, written to Davidson Pipe Supply, Inc., revealed that 24 flanges had been received from WJM. Table 1 provides the specification, size, pressure rating and heat number of these 24 flanges. These flanges were purchased for use in a non-safety related turbine gland supply and exhaust steam piping system. The flanges were never installed and all 24 have been drawn out of stock and segregated by the Quality Control Department. One flange from each heat number was forwarded to a testing laboratory for analysis. This information will be submitted to the utility database established by NUMARC.
