On February 2, 2010, STPNOC met with the NRC staff to discuss an NRC-conducted pilot inspection of STP's digital instrumentation and controls (I&C) design acceptance criteria (DAC) resolution activities. During the agenda item for the closed portion of the meeting, STPNOC presented a schedule of I&C DAC documents availability. STPNOC considers this schedule information confidential commercial property. This letter provides a public version and a proprietary version of the STP presentation materials from the meeting.
