SUNSI REVIEW COMPLETE

The purpose of this modification is to extend the period of performance to 12/30/10 at no additional cost to the Government. Accordingly, the task order is hereby modified as follows:

Page 2, paragraph 2 of Task Order 24 is hereby deleted in its entirety and replaced with the following paragraph:

Task Order No. 24 shall be in effect from 4/02/08 through 12/30/10 with a cost ceiling of \$178,072. The amount of \$170,297 represents the estimated reimbursable costs, and the amount of \$7,775 represents the fixed fee.

All other terms and conditions remain unchanged.
