The licensed operator examination schedule, previously submitted to the NRC by Reference 1, will not be sufficient to support the station's desire for licensed operators.

The NRC administrated a license examination at this facility in December 1995. The examination preparation materials are current except for some procedural changes. The Authority will transmit the updated licensed operator examination materials to the NRC by February 15, 1996. The certified operator license applications for the four (4) SRO candidates who are scheduled to take the April 1996 NRC examination were previously submitted to the NRC by Reference 2, and then withdrawn by Reference 3.
