The purpose of this modification is to provide incremental funding in the amount of \$80,306.00 thereby increasing the total obligations from \$330,000.00 to \$410,306.00. Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$410,306.00, of which \$383,365.00 represents the estimated reimbursable costs, and the amount of \$26,941.00 represents the fixed fee.


