SUMMARY

We have reviewed your letter dated November 12, 2009, requesting an amendment to your byproduct materials license. We find that we need additional information as follows:

**The number of sources you appear to be requesting is 2 for License No. 24-26162-01. We now require a total possession limit for each radionuclide requested, as well as providing the "per source" activity you need, which should match the Sealed Source and Device Registry certificate procured by the vendor. It is acceptable to request more sealed sources than you may actually need immediately, to allow for some growth, so long as the request is reasonable and realistic. Please clarify the number of sources you require and what the maximum activity will be per source. Please also confirm the total possession activity that you are requesting.**

We will be unable to continue processing your request until we receive this information.


